## THE CITY OF CAMBRIDGE (PUBLIC OFF-STREET PARKING PLACES) (AMENDMENT NO. 4) ORDER 2025

Notice is hereby given that Cambridge City Council ("the Council") in exercise of its powers under the Road Traffic Regulation Act 1984 ("the 1984 Act") (as amended) and of all other enabling powers, with the consent of the Cambridgeshire County Council in accordance with Section 39(3) of the 1984 Act and the Traffic Management Act 2004 (as amended) and after consulting with the Chief Officer of Police intend making the above-named Order.

- 1. The effect of this Order is to amend the City of Cambridge (Public Off-Street Parking Places) (Consolidated) Order 2023 as follows:
  - a) Schedule 3 Table 1 and Table 2, and Schedule 4 Table 1 of the Consolidated Order of 2023 is substituted with Schedule 1,2 and 3 of this Order respectively, to reflect the revisions to tariff changes for pay-on-foot and pay and display car parks and changes to business season ticket charges from the date this Order comes into operation.
  - b) Schedule 3 Table 2 of the Consolidated Order of 2023 is substituted with Schedule 4 of this Order from the date this Order comes into operation to reflect the revisions to tariff charges for parking from the date this Order comes into operation.
  - c) Schedule 2 Table 4 of the Consolidated Order of 2023 is substituted with Schedule 5 of this Order and placed in Table 2 of the Order of 2023 to reflect the new controlled hours from the date this Order comes into operation.
  - d) Insert the table in Schedule 6 of this Order into Schedule 3 Table 2 of the Consolidated Order of 2023 to reflect the tariff applicable from the date this Order comes into operation.
  - e) Schedule 3 Table 2 of the Consolidated Order of 2023 is substituted with Schedule 7 of this Order to reflect the tariff change from the date this Order comes into operation.
  - f) Insert the row in Schedule 8 of this Order into Schedule 2 Table 4 of the Consolidated Order of 2023 to reflect the contraventions of this car park
  - g) Insert the row in Schedule 9 of this Order into Schedule 2 Table 4 of the Consolidated Order of 2023 to reflect the contraventions of this car park
  - h) Insert the Plans in this Order into the Consolidated Order of 2023 to reflect additional areas covered by the Order
